General Information

Camp Dates and Hours:

- o The camp will run on Monday to Friday, from 28th October 2024 to Friday 2nd 2024.
- o Daily hours are from 10:00 to 15:00.
- o Children can be dropped off for no additional charge between 08:00 and 17:30.
- The camp and its employees are not responsible for children outside of these hours.

Eligibility:

o The camp is open to children aged from 3 years old to 11 years old.

Registration and Payment

Registration Process:

o Registration is on a first-come, first-served basis.

Fees and Payments:

- o The fee for the camp is £125 per child per week.
- o The daily fee is £32 per child.

Discounts and Reductions:

- A discount of 20% is available for families registering more than one child.
 The discount of 20% is only applicable to any additional sibling booking with the first full paying child.

Cancellation and Refunds

Cancellation Policy:

- Cancellations made before 1 week of the camp start date will receive a full refund.
- o Cancellations made within 1 week of the camp start date will not be eligible for a refund.
- The camp reserves the right to cancel the program due to unforeseen circumstances, in which case a full refund will be provided.

Medical and Health Policies

Medical Information:

- o All medical conditions must be clearly stated on the registration form.
- o Parents/guardians must notify the camp of any changes to their child's medical condition prior to the start of the camp.
